Grabber Student,

The CARES Act Pub L. No. 116-136 has offered higher education institutions emergency funds to disburse to students in need. This emergency funding is now available to *all* students who are Title IV eligible (for Pell Grants and/or Direct Loans) and were enrolled *at any time after* March 13<sup>th</sup>, 2020. These funds are available from the U.S. Department of Education and are Grants. Therefore, there is no requirement that you repay these funds.

Emergency funding is be based on need. The attached application will ask you to list your expenses in connection with the COVID-19 virus as well as any expenses that you incurred to participate in the distant education. Expenses have to be incurred *after* your enrollment occurred.

Expenses could be as a result of you or a family member losing employment, housing, technology, health care, and childcare or childcare food expenses. If necessary, we may ask you for support of some of your expenses. You may be eligible for these grants although you have not suffered directly or been ill as a result of the virus.
