The CARES Act Pub L. No. 116-136 has offered higher education institutions emergency funds to disburse to students in need. We have received these funds and are anxious to be able to provide them to you. This emergency funding is available to *all* students who were Title IV eligible (for Pell Grants or Direct Loans) and were enrolled on March 13<sup>th</sup> or later. Emergency funding will be based on need. The attached application will ask you to list your expenses in connection with the COVID-19 virus as well as any expenses that you incurred to participate in the distant education. Expenses could be as a result of you or a family member losing employment or it could include subscribing to an internet service that you did not have previously. Additional examples of COVID related expenses could be food, housing, technology, health care, and childcare expenses. If necessary, we may ask you for receipts for some or all of the expenses.

If Denise is unavailable, or not in the building, please slide your application underneath Denise's door in the hallway marked "Director's Office" (we will be doing multiple checks every day). After we receive applications we will review and promptly disburse funds to eligible students and former students. Please contact me via email with any questions.
